1. Ulrich Roux & Associates law firm (“URA”) was formally appointed as the legal representative of Mirror Trading International (“MTI”) on 28 April 2020. We were appointed by Cheri Ward, head of communications and marketing for MTI, to assist MTI with the following:
 - a. Legal compliance in terms of the SA Companies Act 71 of 2008.
 - b. Legal assistance with the drafting of contracts and general litigation.
 - c. Legal representation pertaining to correspondence received and interaction with the Financial Sector Conduct Authority (“FSCA”).
2. URA made it clear from the outset that we were in no position to provide potential clients with financial advice as to whether they should invest with MTI, as we are not financial advisors, nor are we specialists in Bitcoin or any other form of cryptocurrency trading.
3. URA is in no way affiliated to MTI and can accordingly not be held responsible or liable for any profit or loss arising from any investment made, using the MTI platform. In addition to this, we confirm that our firm is not a member of MTI,



nor are we involved in their internal business structure. URA is an independent law firm, with the sole mandate of providing legal assistance to MTI on a contractual basis, as set out above.

4. It has recently come to our attention that the CEO of Mirror Trading International, Mr Johan Steynberg (“Steynberg”), is no longer in South Africa, and that the remaining members of the MTI management team have no way of contacting Steynberg. In addition to this, we have been informed that MTI members are not receiving their withdrawals, as they have in the past.
5. Despite numerous requests, URA has not received clear instructions pertaining to the above. Legal representatives only act upon instructions of their clients and accordingly we are left with no choice but to withdraw as the attorneys of record for Mirror Trading International, as we hereby do.
6. URA has been in contact with the FSCA and will continue to provide assistance and co-operation to the FSCA pertaining to their ongoing investigation into MTI, subject to the parameters of legally privileged information.
7. URA cannot provide any clarity pertaining to the investments made by members of MTI, as this was not part of our mandate and we have no knowledge pertaining to same. All queries in this regard must be forwarded to support@myMTIclub.com.
